The Lewisham (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Consolidation) (Amendment No *)
Order 202* The Lewisham (Charged for Parking Places) (Consolidation) (Amendment No *) Order 202*

The Council of the London Borough of Lewisham proposes to make the above Traffic Regulation Orders under the Road Traffic Regulation Act 1984 (as amended). **PTO 1057**

- The effect of these proposals will be to:-
 - (a) Introduce dockless electric scooter and pedal cycle parking places in the lengths of roads specified in Schedule 1 to this Notice, to facilitate dockless cycle hire scheme, for the leaving of electric scooters and pedal cycles hired through authorised operators. Each dockless parking bay will be 5m in length and 2m in length, unless otherwise specified;
 - (b) Introduce new 'at any time' waiting restriction (double yellow lines) in the lengths of roads specified in Schedule 2 to this Notice;
 - (c) Introduce footway electric scooter and pedal cycle parking areas in the following roads: (i) Dartmouth Road (1) outside Shippenham Court; (2) outside Forest Hill Pools; (ii) Perry Vale opposite 31 City Walk Apartments; (iii) Jews Walk at the junction with Kirkdale; (iv) Adelaide Avenue at the junction with Eastern Road; (v) Belmont Hill west of Bus Stop K (Lockmead Road).
- 2. Where a new restriction has been proposed in the same length of road, the existing restrictions will be replaced by those proposed restrictions.
- 3. Copies of the draft Order, plans and Statement of the Council's Reasons for proposing to make the Order may be viewed either though the lewisham.traf-fweb.app website or obtained by emailing a request to trafficorders@lewisham.gov.uk quoting reference 'PTO 1057'.
- 4.
