

ROAD TRAFFIC REGULATION ACT 1984

THE A23 GLA ROAD AND SIDE ROADS (STREATHAM HIGH ROAD AND SIDE ROADS, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) NOTICE 2024

- 1. Transport for London, in consultation with the London Borough of Lambeth hereby gives notice that it has made the above-named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable safety improvement scheme works to take place on or near a section of the A23 Streatham High Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting or proceeding in a northerly direction on the A23 Streatham High Road between its junctions with Pinfold Road and Woodbourne Avenue;
 - (2) entering, exiting or proceeding in a southerly direction on the A23 Streatham High Road between its junctions with Leigham Court Road and Pinfold Road, marshalled local access only between Leigham Court Road and Leigham Avenue;
 - (3) proceeding in a northerly direction on the A23 Streatham High Road at its junction with Gleneldon Road;
 - (4) entering, exiting, stopping or proceeding on Gracefield Gardens between its junction with its junction with A23 Streatham High Road and the extended eastern building line of Astroria Parade, Streatham High Road;
 - (5) entering or exiting Becmead Road at its junction with A23 Streatham High Road;
 - (6) proceeding in a westerly direction on Leigham Avenue between its junctions with the Endsleigh Mansions access road and the A23 Streatham High Road;
 - (7) stopping in the Loading and Disabled Persons' Vehicles Bay outside Nos. 6 to 8 Streatham High Road;
 - (8) stopping in the Loading and Disabled Persons' Vehicles Bay outside Nos. 146 to 156 Streatham High Road;
 - (9) stopping in the Parking and Disabled Persons' Vehicles Bay outside No. 5 Leigham Avenue;
 - (10) stopping in the Parking and Disabled Persons' Vehicles Bay outside Nos. 20 to 29 The High Parade, Streatham High Road;
 - (11) stopping in the Loading Bay outside Nos. 130 to 134 Streatham High Road;
 - (12) stopping at the southern side of Pendennis Road between the extended western building line of No. 6 Pendennis Road and its junction with A23 Streatham High Road;
 - (13) turning right from Mount Ephraim Road onto Streatham High Road;

This Order will also:

- (14) allow all vehicles to use the southbound bus lane on the A23 Streatham High Road between a point 75 metres south of Leigham Avenue and its junction with Pendennis Road;
 - (15) allow all vehicles to use the northbound bus lane on the A23 Streatham High Road between its junction with Becmead Avenue and Kingscourt Road;
 - (16) close the pedestrian crossings on A23 Streatham High Road at its junction with Becmead Avenue/Pendennis Road and at its junction with Woodbourne Avenue;
 - (17) allow all vehicles to turn right from Prentis Road onto A23 Streatham High Road.
 - (18) allow all vehicles to enter Glendon Road from the northbound carriageway of Streatham High Road.
- Works will be phased such that some restrictions will apply only at certain times.

Marshals will be available to asset pedestrians and vehicles when required. The Order will be effective at certain times between 12:01 AM on 21st December 2024 until 5:00 AM on 11th July 2025 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs for northbound traffic in Streatham High Road Diversion route A via Streatham High Road southbound, Streatham Common North and Leigham Court Road to normal route of travel, Or via Becmead Avenue, Garrad's Road and Tooting Bec Gardens to Diversion route A above, Or via Gleneldon Road and Stanthorpe Road to Diversion route A above. For southbound traffic in Streatham High Road Diversion route B via Streatham High Road northbound, Drewsted Road, Railway Bridge, Sternhold Avenue, Leigham Court Road and Streatham Common North to normal route of travel, Or via Leigham Avenue and Leigham Court Road to Diversion route B above. For traffic in Gracefield Gardens via Woodleigh Gardens, Leigham Avenue and Leigham Court Road to Diversion route B above. For traffic wanting Gracefield Gardens via Streatham High Road southbound, Pendennis Road and Newcome Gardens to normal route of travel and in reverse.
