## **ROAD TRAFFIC REGULATION ACT 1984**

THE A22 AND A23 GLA ROAD AND SIDE ROADS (GODSTONE ROAD AND PURLEY WAY, LONDON BOROUGH OF CROYDON) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING AND BANNED TURNS) ORDER 2025

- I. Transport for London in consultation with the London Borough of Croydon hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable drainage remedial works to take place on the A22 Godstone Road and A23 Purley Way.
- 3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting or proceeding northbound on the A23 Purley Way between its junctions with Foxley Lane and Russell Green Close;
  - stopping on Russell Hill Road between its junctions with A23 Purley Way and Russell Hill Place;
  - (3) stopping on Bansted Road between its junctions with A23 Brighton Road and Foxley Lane;
  - (4) stopping on the A22 Godstone Road between its junctions with Whytecliffe Road South and Sylverdale Road;
     (5) stopping in the Parking and Disabled Persons Vehicles bay outside
  - Nos. 8 to 30 Godstone Road;(6) stopping on the southern arm of Dale Road between its junction with A22 Godstone Road and the extended common boundary of
  - with A22 Godstone Road and the extended common boundary of No. 39 Dale Road and No. 72 Godstone Road;(7) turning right from Whytecliffe Road South onto High Street Purley;
  - (8) turning left from the A23 Purley Way onto Edgehill Road;
  - (9) turning right from the A22 Godstone Road onto Downs Court Road;

The Order will also:
(10) permit southbound traffic to use the northbound carriageway of

- the A23 Purley Way between a point 70 metres north of its junction with Highfield Road and a point 2.5 metres north of the extended northern building line of No. 30 Wyvern Road. Traffic rejoining the southbound carriageway of Purley Way is permitted to cross the double white lines;
- (11) suspend the pedestrian crossing on A22 Godstone Road between its junctions with Sylverdale Road and St James' Road;(12) suspend the pedestrian crossing on A22 Godstone Road south of
- its junction with Foxley Hill Road;
  (13) suspend the western footway of A22 Godstone Road outside of
- No. 50 Godstone Road and its junction with Dale Road (northern arm).

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 8:00 AM on 17th

March 2025 until 5:00 AM on 3rd September 2025, or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
  - any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs via Russell Hill Road, Brighton Road, A22/A23 roundabout, A235 Brighton Road, Southbridge Road, Davenant Road, A232 Croydon Flyover, Duppas Hill Road and Stafford Road to normal route of travel. Or via Pampisford Road and Edgehill Road to normal

route of travel.
