## **ROAD TRAFFIC REGULATION ACT 1984**

THE A24 GLA ROAD AND A219 GLA SIDE ROAD (MERANTUN WAY MORDEN ROAD. LONDON **BOROUGH** OF MERTON) (TEMPORARY PROHIBITION OF TRAFFIC AND BANNED TURNS) **ORDER 2025** 1. Transport for London in consultation with the London Borough of Merton

- hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3. 2. The purpose of the Order is to enable carriageway build-out to facilitate
- a new staggered crossing and associated signal modification works to take place on A24/A219 Morden Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
  - (I) entering, exiting or proceeding on the southbound carriageway of the A219 Morden Road between its junction with The Path and Merantun
  - (2) entering, exiting or proceeding on the northbound carriageway of the A24/A219 Morden Road between its junction with Jubilee Way and The Path:
  - (3) turning left from the southbound carriageway of the A219 Morden Road onto Merantun Way;
  - (4) turning right from the northbound carriageway of the A24 Morden Road onto Merantun Way;
  - (5) turning right from Merantun Way onto the A219 Morden Road; The Order will also close the northbound bus lane on the A24/A219 Morden Road between its junction with Jubliee Way and The Path.

Works will be phased such that some restrictions will apply only at certain times. The Order will be effective at certain times between 7:30 AM on 12th

April 2025 until 5:00 PM on 14th January 2026 or when the works have been completed whichever is the sooner. The prohibitions will apply only

during such times and to such extent as shall from time to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of:

- (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes; (2) anything done with the permission or at the direction of a police
- constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs for southbound traffic on Morden Road via Merton High Street, Priory Road, Christchurch Road and Merantun Way to normal route of travel. Or for traffic in High Path wanting to travel southbound on Morden Road via Morden Road northbound to the route above. For northbound traffic on Morden Road via Merantun Way, Christchurch Road, Priory Road and Merton High Street to normal route of travel. For traffic on Morden Road wanting to turn left into Merantun Way

via Morden Road southbound, Morden Hall Road Roundabout and Morden Road northbound where the right turn into Merantun Way will be
